Does this website use cookies to keep track of my information?

Yes, this website uses cookies. A cookie is a small text file that is placed on your hard drive. Cookies contain information, including personal information, that can later be read by a web server in the domain that issued the cookie to you. The information that cookies collect includes the date and time of your visit, your registration information, session identification number and your navigational history and preferences.

In some cases, our third-party service providers may use cookies on our sites. We have no access to or control over these cookies. This privacy statement covers the use of cookies by BoxedArt.com and Big Resources, Inc. only, and does not cover the use of cookies by third parties.

What types of information does this website collect?

We only collect personal information about you after you have provided us with your consent to collect that specific information. By voluntarily providing this information to us, you consent to the collection and use of your personal information as set out in this privacy policy.

1. NON-PERSONAL INFORMATION. We collect the following types of non-personal information and navigational information, which may be collected automatically as part of the site's operation:

- Information about the user's computer system, such as the web browser type and language, IP address, internet service provider, and operating system;
- The website that referred you to us and access times;
- Information about the pages you view;
- The links you click;
- The number of times you visit our site in a month;
- The size of the files you look at; and
- Other actions taken in connection with the site.
- Demographic information (i.e. your occupation, hobbies, gender, or interests) may be collected and linked to your personal information.

2. PERSONAL INFORMATION. Personal information that we collect may include the following:

- Traditional contact information such as mailing address, phone number, and fax number;
- Internet contact information such email addresses;
- Information collected when you make a purchase, including your billing address.
- Non-financial identification information, such as your member username and password combination.

NOTE: You may elect not to provide certain personal information, but doing so may limit, or otherwise make unavailable, certain products and/or services to you.

Why is this website collecting the information?

We collect the information for the following purposes:

- To process your transactions;
- To provide customer service;
- For website administration purposes.

We may also send you surveys, newsletters, product updates, or marketing communications, or offers that may be of interest. If you do not wish to receive certain website notifications and announcements, you may make this election by logging into your account and updating your notification preferences accordingly or follow the unsubscribe instructions that are detailed within the email notifications. Please keep in mind, however, if you choose not to receive marketing communications or site announcements and updates, you will continue to receive transactional or account communications.

Personal information collected by BoxedArt.com and/or Big Resources, Inc. may be stored and processed in the United States of America or any other country in which BoxedArt.com, Big Resources, Inc., their affiliates, subsidiaries, or other agents maintain facilities, and by providing us with your personal information and using our sites or services, you consent to any such transfer of information outside of your country.

Who will receive the information? Except as set out in this privacy policy, BoxedArt.com does not disclose or sell your personal information to any third-parties. Please review the possible and defined disclosures of your personal information below:

1. We may disclose your personal information to third-party service providers who perform services on our behalf. For example, we may hire other companies to handle the processing of payments, to provide data storage, to host websites, to fulfill orders and shipments, to assist in marketing, to conduct audits, etc. Those third-party service providers (i) shall be permitted to obtain only the personal information they need to provide the service, (ii) must protect personal information to the same extent as BoxedArt.com and Big Resources, Inc., and (iii) shall be prohibited from using it for any other purpose.
2. Information about our customers, including personal information, may be disclosed as part of any merger, acquisition, or sale of the company and/or its assets, as well as in the unlikely event of insolvency, bankruptcy, or receivership, in which personal information would be transferred as one of the business assets of the company. We will notify you of such an occurrence as described in the "Changes to This Privacy Policy" section below. We reserve the right to disclose your personal information if required or permitted to do so by law.
3. The information will be shared with the following parties:
 - Our internal staff and our direct agents.

How long will the information be kept?

Information collected may be retained for as long as it is reasonably required for the purposes it was collected. Session data expires at the end of a visit. Logged data is reviewed for errors, and rotated frequently. Member data is stored for long term customer service purposes.

How can I access and review my personal information?

If you would like to review or revise information that you previously provided to us, you may access and change your personal information by logging into your account and clicking "Account Details". You may also contact our customer service department directly by clicking the "Support" tab located within the top navigation on all pages of the website.

What if I think there are inaccuracies in my information?

If for some reason we have violated our privacy policy, we will correct the error as soon as you notify us.

How is my personal information securely retained?

We follow generally accepted industry standards to help protect your personal information, including without limitation:

- Limiting access to your personal information to those employees or personnel that require it to provide services to you;
- Requiring employees or personnel to sign confidentiality agreements to protect customer and other confidential information;
- Ensuring that third-part service providers sign confidentiality agreements to maintain the confidentiality of your personal information and not to use it for any unauthorized purposes;
- Encrypting credit card information on our order forms using secure socket layer (SSL) technology; and
- Storing your personal information in secure computer systems which protect it from unauthorized access or use.

Therefore, while we strive to protect your personal information, we cannot guarantee its absolute security. If a password is used to protect your account and personal information, it is your responsibility to keep your password confidential at all times.
